Dear Trish

Thank you for your recent email on behalf of the Northwest regional recreational fisheries forum. In your email you endorse the 17 November 2009 letter that was sent to me by the Northland Non-commercial Fishing Forum regarding observer coverage on foreign charter vessels (FCVs) in New Zealand fishing waters.

I would like to take this opportunity to confirm the response that I gave to the Northland Non-commercial Fishing Forum in my reply to their letter.

In 2008 the Ministry of Fisheries (the Ministry) consulted on a range of measures for the management of FCVs operating in New Zealand's EEZ. In June 2008 the Ministry's chief executive made a number of decisions relating to FCV management. One decision was the creation of a standard setting out the minimum acceptable level of food, accommodation and amenities that must be provided for observers on board all vessels over 46 metres in length, both domestic and foreign charter.

A second decision was to approve the implementation of a risk-based approach for observer coverage of FCVs. The chief executive considered that increased observer coverage of high risk vessels was the most effective way to ensure the activity of these vessels did not compromise the integrity of New Zealand's management regime.

The Ministry has an annual plan for observer coverage. Almost all observer coverage covered by the plan is funded by cost recovery levies that are paid by quota owners. The costs of any additional observer coverage, for example coverage of high risk FCVs, are charged directly to the operator of the vessel in question. I am satisfied that this annual plan, together with the risk-based approach, means that the current level of observer coverage is adequate for the fisheries that the FCV fleet operates in. However, I can confirm that the Ministry is currently exploring the option of full observer coverage with deepwater quota owners.

I would also note that current observer coverage in many of the fisheries that the FCV fleet operates in is high and it is not unusual for 30-40% of these fishing trips to be observed, particularly in the squid and jack mackerel fisheries. The level of coverage amongst the FCV fleet is considerably higher than the coverage in most of the inshore fisheries.

Thank you for expressing your concerns to me. I understand the nature of the concerns that non-commercial stakeholders have regarding FCVs. However, I remain satisfied that the measures in place governing the FCV fleet will ensure the long-term sustainability of our fisheries resources.
