Joint Memorandum Of Counsel In Relation To Timetable May It Please The Court:

- Counsel for the Appellants seek a short extension to the dates for the appellant to file written submissions and for preparation of the draft case on appeal and bundle of authorities.
- 2. An abridged timetable issued on 29 October 2008. The hearing date has been allocated for 12 February 2009.
